Mr. Kevic Anant Setalvad, one of the Promoters of the Company tendered 13,452 shares held by him. Out of which, 7,719 shares were accepted for buyback on a proportionate basis. 3. As a result of buyback of share from Mr. Kevic Setalvad, Promoter, shareholding of promoters increased from 65.89% to 68.17% (a change of less of 5%). 4. 3140 shares transferred in IEPF have been shown under category "Non Institution"- "Any Others". As voting has been frozen as per rules the same has been deducted from voting rights of public. 5. 25989 Shares held in unclaimed securities suspense account are shown under the category "Non Institution"- "Any Others" but from the voting rights they have been omitted as voting is frozen in this case. 6. Shares in the name of Vikram Swarup are held in the capacity of Trustee of Swarup Family Trust. Name of First holder is Vikram Swarup on behalf of Swarup Family Trust.</p>
